Medical malpractice occurs when a medical provider or health care company fails to provide adequate medical services or makes a mistake that causes harm to a patient. State laws define and regulate medical malpractice. State laws usually require a medical malpractice lawsuit to be filed within a certain time after the event or injury. What are the types of medical malpractice? There are several different types of medical malpractice, but these are the most common: A physician misprescribes a medication. A physician prescribes the wrong medication, or gives incorrect instructions to the patient. A hospital administers the wrong medication to a patient. A hospital administers the correct medication, but the patient suffers from an allergic reaction. A hospital administers the correct medication, but the patient suffers from a medication error. Hospitals often administer medications to the wrong patient. Most medical malpractice lawsuits involve a hospital error. Can you win a medical malpractice lawsuit? Whether you sue the hospital or health care provider, your medical malpractice attorney must have the facts of your case. Medical malpractice lawsuits usually take at least six months to a year to resolve. How much do I need to pay for a medical malpractice attorney? You don't have to pay for your medical malpractice attorney. State laws give you the right to choose your own lawyer. If you don't choose your own lawyer, the court may make that decision for you. How do I choose a medical malpractice attorney? You can choose your own medical malpractice attorney, or hire a lawyer recommended by a medical professional. What should my medical malpractice attorney do for me? You have the right to attend all hearings. The judge will decide whether to grant summary judgment. Hospital and health care providers often offer settlement before the case goes to trial. What medical malpractice lawsuit types are available?
